Township of Douro-Dummer By-Law No. 2001 - 72

BEING a By-Law to regulate the holding of certain public entertainment, parades, festivals, and exhibitions within the Corporation of the Township of Douro-Dummer.

WHEREAS the Council of the Corporation of the Township of Douro-Dummer deems it expedient to licence and regulate the holding of public entertainment, parades, festivals, exhibitions, and places of amusement within the Corporation of the Township of Douro-Dummer;

AND WHEREAS the authority for doing so is contained in the Municipal Act, R.S.O. 1990, C. M-45, as amended, Section 102 and Section 236 (6) thereof;

NOW THEREFORE, the Council of the Corporation of the Township of Douro-Dummer enacts as follows:

1. In this By-Law:

A public entertainment, parade, festival or exhibition held for "charitable purposes" means a public entertainment, parade, festival or exhibition held for, or its proceeds are used for any one or more of the following purposes:

- 1.1 the relief of poverty;
- 1.2.1.1 the advancement of education;
- 1.2.1.2 the advancement of religion;
- 1.2.1.3 any purposes beneficial to the community not falling under the foregoing heading, providing such purposes are in the interest of social welfare and are for the public benefit.
- 2. Before any person, corporation, organization, or association may hold or conduct a public entertainment, parade, festival, or exhibition within the limits of the Corporation of the Township of Douro-Dummer, which public entertainment, parade, festival or exhibition is not for a charitable purpose, the said person, corporation, organization or association shall:
 - 2.1 Obtain a licence under this By-law from the Clerk of the Corporation of the Township of Douro-Dummer authorizing the holding of such public entertainment, parade, festival or exhibition.
 - 2.2 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer an amount of money estimated by the Officer commanding the Central Region, Peterborough County Detachment of the Ontario Provincial Police as sufficient to provide for the cost of adequate additional police protection during the period of the said entertainment, parade, festival, or exhibition or any or all of them, during which such police protection shall, in the opinion of the said Officer, be necessary.
 - 2.3 Deposit with Clerk of the Corporation of The Township of Douro-Dummer a certified copy of a comprehensive general liability policy of insurance issued by an insurer **satisfactory to the Council for the Corporation of the Township of Douro-Dummer** and who is licensed to do business in Ontario which provides for limits of protection of \$10,000,000.00 in respect of the public entertainment, parade, festival, or exhibition in question, which provides coverage including bodily injury, property damage, and non-owed auto insurance, which names the Corporation of the Township of Douro-Douro as an insured party and which provides coverage for a period equal to the duration of the public entertainment, parade, festival or exhibition in question plus one (1) day before the commencement and one (1) day after conclusion of the public entertainment, parade, festival or exhibition in question.
 - 2.4 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer an amount of money to be fixed by the relevant authority where the said public entertainment, parade, festival or exhibition is held, sufficient to repair anticipated minor damage and the cleaning of building and grounds after the

conclusion of such public entertainment, parade, festival or exhibition, so that such buildings and grounds, may be restored to their previous state without cost to the Corporation of the Township of Douro-Dummer or the Board or body responsible for the administration of such buildings or grounds. This deposit shall be in the form of a certified cheque payable to the Township of Douro-Dummer or an unconditional irrevocable letter of credit.

- 2.5 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer a certificate in writing from the Chief Inspector of the Peterborough County-City Health Unit and/or the Ministry of the Environment that all health and sanitation requirements for the said public entertainment, parade, festival or exhibition, or place of amusement have been provided.
- 2.6 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer a certificate in writing from the Township of Douro-Dummer Fire Chief that all fire safety and first aid matters for the said public entertainment, parade, festival or exhibition, or place or amusement have been provided.
- 2.6.1 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer an amount sufficient to cover the costs of the provision of fire protection before, during and after the event as well as sufficient to cover the fire department for any losses that may occur during, because of, or as a result of the event.
 - 2.7 Pay to the Clerk of the Corporation of the Township of Douro-Dummer the licence fee hereinafter provided.
 - 2.8 At least sixty (60) days prior to a special event taking place, provide written notice of the location, nature and date of the event, and the date and time of a public meeting to be held, to all property owners within 500 metres of the property upon which the special event is to be held, and to all property owners within 500 metres of any properties that are to be used in conjunction with the special event, and thereafter file copies of said written notice with the Clerk of the Township of Douro-Dummer.
- 2.8.1 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer an amount sufficient to cover the costs of the public meeting(s).
 - 2.9 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer a certificate in writing, satisfactory to the Council of the Corporation of the Township of Douro-Dummer, from a Bondable Security Company that provision has been made for sufficient security personnel during the period of the said entertainment, parade, festival, or exhibition in question.
 - 2.10 Deposit with the Clerk of the Corporation of the Township of Douro-Dummer a certificate in writing from the Chief Building Official for the Township of Douro-Dummer, that all buildings or structures that are constructed or placed on site for the event, comply with the Ontario Building Code.
- 2.11 Deposit with the clerk of the Corporation of the Township of Douro-Dummer a list of all events, displays, etc. that are to take place in conjunction with, or as part of the event, and such list must be approved by the Council of the Corporation of the Township of Douro-Dummer before the licence for the event is issued.
- 3. No licence shall be issued by the Clerk of the Corporation of the Township of Douro-Dummer for such public entertainment, parade, festival or exhibition until the provisions of Section 2 above have been complied with in full.
- 4. The fee for a licence under this By-Law for any public entertainment, parade, festival, or exhibition, which is not held for a charitable purpose, is THREE HUNDRED DOLLARS (\$300.00) per day or part thereof.
- 5. Any person who contravenes any provision of this By-Law is guilty of an offence and shall be liable upon conviction to a penalty not exceeding FIVE THOUSAND DOLLARS, exclusive of cost, at the discretion of the Presiding Official. Any such penalty shall be recoverable pursuant to the provisions of the

Provincial Offences Act, R.S.O. 1990, Chapter P. 33. In addition to any other remedy to any penalty imposed by this By-Law, the court in which the conviction has been entered, and any court of competent jurisdiction thereafter, may make any order prohibiting the continuation or repetition of the offense by the person convicted pursuant to the provisions of Section 327 of the Municipal Act, R.S.O. 1990 Chapter M.45.

- 6. This By-Law does not apply to any public entertainment, parade, festival or exhibition which is held or conducted:
 - on the allowance of a public highway owned by the Corporation of the Township of Douro-Dummer;
 - on or in a park or recreational facility owned and/or operated by the Corporation of the Township of Douro-Dummer.
- 7. The invalidity of any section, portion of a section, paragraph, or portion of a paragraph of this By-Law shall not affect the validity of any other provision of this By-Law.
- 8. That By-law Number 1982-34 of the former Township of Douro, and By-law Number 13-1992 of the former Township of Dummer are hereby repealed.
- 9. This By-Law shall come into effect on the date of the passing hereof, subject to the provisions of Section 34 of the Planning Act, 1990 as amended.
